MEASURE SUBMITTED TO VOTE OF VOTERS

PROPOSITION A:

Shall Improvement Area No. 7A1 (the "Improvement Area") of Community Facilities District No. 93-1 of the City of Beaumont (the "Community Facilities District")

- (i) provide for a special tax to finance all or a portion of the design, acquisition, construction and equipping of certain real and other tangible property with an estimated useful life of five years or longer authorized by the Community Facilities District Act of 1982 (the "Act"), including transportation facilities, sewer treatment plant, Westside fire station, electrical utility substation, electrical utility extensions, San Timoteo watershed management projects, domestic water system, recycled water system and appurtenant facilities, including engineering reports and studies, utilities, fees and permits in connection therewith, or capital facility or mitigation fees representing such facilities, all required to facilitate development of the property within the Improvement Area, and/or the payment of bonded indebtedness issued to construct or acquire such facilities, including financing costs and incidentals, all as more particularly described in Exhibit B to Resolution No. 2014-07 (the "Resolution") adopted by the City Council of the City of Beaumont on March 18, 2014,
- (ii) incur honded indebtedness in the principal amount of not to exceed \$25,000,000, provide for an account into which such special tax levies be deposited and provide that an annual report be filed with the City Council as required by law,
 (iii) have an appropriations limit in the amount of \$4,000,000 per fiscal year established in connection therewith, and
- (iv) be authorized to levy a special tax with a maximum rate and method of apportionment of special tax as provided in Exhibit C to the Community Facilities District Report, ordered by the Resolution, which is incorporated by reference herein, to pay for services and facilities and/or to pay current and future principal of and interest on bonds and the annual administration expenses of the City, the Improvement Area and the Community Facilities District in determining, apportioning, levying and collecting the special tax, and including the repayment of funds advanced to or on behalf of the Community Facilities District?

Consider extending years to lower annual payments by a vote of registered voter residents


OPTIONS
